

2.1 Environmental policy sequa

sequa's environmental responsibility and motivation stems from its goal of sustainably improving the living and working conditions of as many people as possible.

sequa wants to ensure that the development opportunities for future generations of the world are preserved and that their living conditions do not deteriorate due to the loss of natural resources or the threat of climate change.

sequa's actions and decisions should be determined by a responsible approach to the environment. The company's environmental policy takes into account the requirements of customers, shareholders and partner organisations and is a team task for the company management and all employees.

Environmental management is therefore an integral part of sequa's business activities. We want to systematically document and monitor the impact of our work on the environment. A regular audit in accordance with EMAS will support us in this endeavour.

We are committed to continuously improving our environmental performance, avoiding environmental pollution and complying with the applicable environmental obligations and requirements. To this end, we set ourselves environmental targets and define measures to achieve these targets.

Our environmental policy guidelines are

- 1. **Climate neutrality:** We want to achieve the goal of climate-neutral business activities.
- 2. **Environmental policy is teamwork:** We want to promote employee awareness and personal responsibility and rely on close involvement and active participation of employees in the implementation and further development of our environmental goals and environmental measures.
- 3. **Economical use of energy and raw materials:** We want to use energy (currently electricity and gas) and raw materials (especially water) as sparingly as possible at our administrative site in Bonn and at all of the company's project sites.
- 4. **Promoting the circular economy:** We want to avoid waste as far as possible and recycle unavoidable waste wherever possible.
- 5. **Economical use of materials:** We want to use materials (e.g. paper) as sparingly as possible.
- 6. **Sustainable procurement**: When procuring materials and equipment, we want to pay attention to cost-effectiveness, economy and sustainability criteria.
